RESOLUTION

Approval of "PHREB Resolution on the Honoraria Rates of Level 1 and Level 2 Accreditors" per 57th PHREB meeting dated 27 October 2020

Whereas, the Philippine Health Research Ethics Board (PHREB) promotes the establishment of functional and effective Research Ethics Committee (REC);

Whereas, PHREB has the responsibility to monitor and evaluate the performance of RECs in accordance with PHREB procedures and guidelines;

Whereas, in order to perform its monitoring and evaluation function, PHREB through its accreditors, must evaluate the application of RECs applying for Level 1 or Level 2 Accreditation;

Whereas, PHREB recognizes the need to compensate the Accreditors for the documentary work that they do;

Now therefore, PHREB, in consultation with its Committee on Standards and Accreditation (CSA), hereby resolves:

The payment of honoraria to Level 1 and Level 2 Accreditors assessing the applications of the different RECs applying for PHREB accreditation. The evaluation of these applications entails documentary analysis, assessment of compliance to the institution's policies and to the national and international ethical guidelines, and evaluation of action plan and evidence of compliance.

The payment of honoraria for the Lead Accrerator (Team leader) shall be in the amount of *Seventeen Thousand Six Hundred Eighty Pesos (Php17,680.00)* and the Member Accrerator shall be in the amount of *Sixteen Thousand Pesos (Php 16,000.00)* per REC application. The honoraria shall cover the REC's initial submission of application documents and succeeding submissions of action plan and evidence of compliance, until the Accreditation has been awarded (refer to Annex A).

The PHREB hereby approves and promulgates this resolution.


